Call to Order and Approval of Minutes: Chair Neil Castilow called the meeting to order at 1:00pm. Neil called for approval of the July minutes. A motion to approve the minutes was made Mike/Kim. The minutes were approved as written.

New Business/ Old Business:

State Plan Amendment Ohio Statewide System of Early Intervention Services – A request for additional funds was requested by the Early Intervention grantee. The grantee is requesting \$5000 dollars for FY2015 for the production of several videos that will demonstrate the use of technology in the EI field. The grantee supplied details including a budget in a one page document that was given to the committee members. These videos will be unique to the field and have the potential for national distribution.

MOTION: To increase project funds for the Ohio Statewide System of Early Intervention Services grant by \$5,000 to be used for the production of several videos demonstration the use of technology and other resources to assist in providing early intervention practices to remote underserved areas, Bill/ Mike. After a call for discussion, roll call was taken and motion was approved.

2017 – 2021 State Plan Development - Kay provided a review of possible projects discussed at the May and July meeting by committee members for possible funding. A handout was provided with summaries of possible ideas under the areas of Education and Early Intervention, Health, and Child Care. Each area of interest was discussed at length. Members provided thoughts on what would be important to include in plan language. At the end of a lengthy discussion by all, it was decided to fund the following projects:

- Family Support in Early Intervention
- Healthy lifestyles and healthy choices for persons with developmental disabilities
- Better Childcare for children with disabilities

Kay said the committee would meet at least once if not more before November to complete draft language for the State Plan. She said she would email possible dates and times to the committee members for those meetings.

Adjournment: Neil called for a motion for adjournment. Motion to end the meeting was made, Mike/Karen. The meeting adjourned at 2:30pm.
