The transformation from focus groups at the Columbus Urban League to the Statewide Network it is today.

The amendment and collaboration with Central State and Ohio State Universities with the Health Empowerment Technology Project will be an added work for the women of the Triple Jeopardy Project.

Cassandra informed the committee that the H.E.T. grant was a one year grant that started in 2014 and will end in September 2015 and is looking to get re-funded for 2016. She sees this as a major accomplishment for council to continue to pursue.

The opportunity to present to the Outreach Committee and the Executive Committee will give them a chance to see what will be presented at the September Council meeting.

Cassandra shared many stories of how the Statewide Network was created and continues to broaden among the 92 women from Columbus, Dayton, Cincinnati, and

Lima. The goal is not only continued growth but the education for women in technology.

A proposal to get refunded for the 2016 year will be presented at the September Council meeting.

Outreach members reaction to what has been accomplished with this project and the potential growth aspect in this presentation appears favorable.
