III. Comments and Remarks for May 3, 2018

1. Continuous positive feedback concerning the e-diversity Newsletter
2. No plan language changes needed for any of the Outreach Grants/Grantees.
3. Ken Latham briefly discussed the Infant Mortality rate in Ohio. Ohio's Mortality rate is among the Highest in the Country---The Webinar was suggested by staff member Kay Trainor.
